#### **Director Nominations**


It may seem like we just had an election of Directors, and we did! We will be having a second election of officers in 2023 to align with our new calendar-based fiscal year.

Please be sure to use an updated contribution form, as it was updated last April with the current dues amount and the new ESA Foundation Headquarters address.

In addition to annual membership, the Life Active Membership program is available for those who want to further support the Foundation or those who are tired trying to remember to pay annual dues. Individuals, chapters, councils, or organizations interested in becoming Life Active Members make a one-time \$500 donation or two \$250 donations to become Life Active members. The contributions for Life Active Memberships are placed in a fund where the members' annual dues are paid each year as well as earnings from the fund are used to provide funds for the Grant program.

#### **Planned Giving Update**

This year, the ESA Foundation Planned Giving Brochure underwent major updating. The brochure includes information on a variety of ways that Foundation members and friends of the Foundation can start on their ESAF legacy. Although many of these opportunities are designed for estate planning, there are other opportunities that one can take advantage of prior to end of life. Through the new Legacy IRA Act, if you are 70 ½ or older, you are entitled to donate up to \$50,000 tax free to a 501(c)3 charitable organization, such as the ESA Foundation. In addition, if you are 72 or older, and required to take your Required Minimum Distribution from an IRA, you can gift all or part of this distribution tax free to the Foundation. Brief explanations are included in the new brochure but details should be obtained through your personal IRA administrator.

The Planned Giving section of the ESAF Contribution page on the ESAF website (https://epsilonsigmaalpha.org/contribute) has also been revised and updated to offer a downloadable PDF version of the new brochure and also provide a document with details of a variety of ways for including the Foundation in one's estate plans that is more clearly defined. We hope you will take advantage of these easily accessible documents to share with your chapter and state members.

#### **ESA Foundation Making a Difference**

The ESA Foundation is making a difference and continues to be committed and dedicated to the promotion of continuing education through its scholarships and grants. Many students would not be able to pursue their educations without the help of organizations like the Foundation. Others would not be able to enhance their careers without the grants.

I want to share an excerpt from a letter I received from grant recipient Whitney Bryant recently. She says "Thanks, to the generous Vocational Grant awarded by the ESA Foundation, I was able to complete the Intimacy Directors & Coordinator (IDC) Level 3 Intimacy Coordinator Training Program, which leads to certification for those who wish to work professionally as intimacy coordinators in film and television.

The Level 3 training consisted of weekly classes via Zoom and three in-person weekends in New York City. In addition to learning more about on-set safety, consent and boundaries, preparation



and collaboration, contracts, union rules, communicating with actors and production members, and more, our cohort was able to explore and practice choreography, problem solving, and masking over three weekends in Brooklyn and Lower East Side studios.

After more than 15 weeks of instruction, study, practice, and assessment in IDC's Level 3 Intimacy Coordinator Training Program, I am now a certification-pending Intimacy Coordinator. I can now begin working as an Intimacy Coordinator for film and television as I enter the mentoring stage of my training.

In addition to the incredible and essential knowledge and experience gained throughout these past few months, the opportunity and essential knowledge and experience gained throughout these past few months, the opportunity to create invaluable connections and memories with the fellow members of my training cohort and our instructors was invaluable. Thank you, ESA Foundation, for helping make this possible."

# ESA FOUNDATION CALL FOR NOMINATIONS BOARD OF DIRECTORS

In accordance with the ESA Foundation Bylaws, it is the duty of the Nominating Committee to nominate candidates for 3 Directors to fill vacancies on the Board of Directors for an ensuing three-year term. Nominations may be submitted to the Committee up until October 1, of each year. A nominee for Director must hold active membership in the ESA Foundation and be entitled to vote at the time the candidacy is put to a vote of the membership.

**LIMITATIONS**: No Director may serve more than two (2) consecutive 3-year terms unless filling a vacant director position; or hold an elective position on the Executive Board of the International Council of Epsilon Sigma Alpha, or be an employee of the ESA Membership Corporation, or hold an elective position on the Board of Directors of the Epsilon Sigma Alpha Membership Corporation during her/his term of office on the ESA Foundation Board of Directors.

**BASIC FUNCTION:** To actively participate in conducting the business of the Foundation by fulfilling the specific requirements of the Board of Directors; to give time and expertise in planning the future and growth of the ESA Foundation.

#### RESPONSIBILITIES:

- 1. Conduct the business of the Foundation in a professional manner.
- Maintain the integrity of personal and Foundation activity.
- 3. Expand services and conduct projects within the framework of creditable business practices and viable parameters.
- 4. Attend all meetings, including IC convention as a candidate and multi-day meetings at midyear and IC Convention.
- 5. Carry out official and/or committee assignments in ways that meet functional requirements of the Foundation.

#### JOB QUALIFICATIONS:

- 1. Ability to travel to all Board Meetings, the Annual Meeting, and occasionally to IC Leadership or State meetings
- 2. Have a basic knowledge of the ESAF scholarship and grants program or similar programs with other organizations
- 3. Demonstrates leadership ability and willingness to work collaboratively with a diverse team
- Have a working knowledge of word processing, spreadsheet software, electronic file shares (i.e. Dropbox, Google Drive, etc.) and web-based meeting software (i.e. Zoom, WebEx, GoTo Meeting, etc.)
- 5. Demonstrates timely follow through on commitments, open to new ideas, and a passion for the goals of the Foundation
