Turnaround Fund Update

In the Fall Newsletter, the reasons why the Foundation uses the Turnaround Fund were reviewed. The Foundation asks that the Chapters, Districts, Regional and States please continue to use the Turnaround Fund as you have opportunities to donate to charities, particularly as the year comes to a close and you are looking to make donations.

There have been some ongoing concerns regarding the time it takes to get funds back after a check has been sent to headquarters for processing. The Board has heard the concern and are working with the staff to address the concern. The following items have been put into place to help track and identify opportunities for improvements, as well as to better communicate with the originator the status of your request.

- 1. A tracking system has been implemented which includes logging the date the check is sent to headquarters, and the date when the checks are sent back to the originator. We want to gather this data, so we can implement the appropriate changes to shorten the cycle time. This data is reported quarterly to the Board.
- 2. The function that sends an email automatically to the originator once a check has been received was not functioning. That feature has now been fixed, so the originator will know when their check has been received by the staff.
- 3. Lastly, the staff will send the originator an email when the turnaround checks are returned to the sender. This will keep you informed of key milestones on your turnaround fund request.

We have also created a Zeffy code which you can use to process Turnaround Funds. You will need to complete the form online, which is the same as the hard copy form. This can help expedite your request as there would be minimal delays from the postal system. The following is the Zeffy QR Code and link.

Please keep in mind that these are initial steps in addressing the cycle time item. While the data is limited, tracking from the beginning of August shows that the average time from post mark on the sender's envelope to sending the checks out is two weeks. We will continue to track to identify bottlenecks and make changes. If you have any questions, concerns or comments, please reach out to one of the Directors.
